Dear Friends of the City Center,

In preparation for writing this letter I took some time and read many of the past letters that have preceded the annual report. While there were several different authors over the years, every letter is filled with optimism for the future of City Center and the City of Saratoga Springs. This letter, the first I have written, reflects the same sense of optimism and positivity for the future of the City Center and the community it serves.

This past year the City Center staff has worked very hard. In 2017 the City Center hosted 175 events, this is a record number of events for the facility. These 175 events translated to 333 days of building use, this exceeded the previous record by thirteen days. The sales staff made up of Susan Baker, Rebecca Vickery and Lauren Rowland have worked very hard to achieve this and are pushing to set another record in 2018.

The end of 217 also had an internal staffing change that will be important to the long-term operation of the City Center. Shelby King was promoted to the position of Operations Manager after a year of going above and beyond. The back of house staff along with Shelby serviced the over 160,000 visitors that came through the facility last year.

This year we also said goodbye to Joe Dalton as the Chair of the City Center Authority. Joe was a great asset to the City Center and helped make my first year as Executive Director as successful as it has been.

I personally want to thank Joe Dalton and the entire City Center Authority for the support and leadership they have shown, both as members of the Authority and in the community. They along with the Mayor, City Commissioners and citizens of Saratoga Springs keep this community an unrivaled destination in New York State.



2017 Accomplishments

2017 was an exciting year for the City Center. January 2017 began the tenure of Ryan McMahon as the City Center's Executive Director. The sales team worked diligently to keep the building full and to make sure all of our clients had a positive experience. The sales team has been working with a focus to establish our venue as the meeting space many of the limited service hotel properties do not have to offer. In the past many of these hotel partners would not bid on a conference because they could not accommodate their meeting needs; we have been working to stay top of mind with our partners and to be the meeting space they don't have within their buildings. The walkability of Saratoga provides us with a unique opportunity and we continue to make sure that aspect of our beautiful city is considered by all who are planning an event. In addition, the sales team has put a special emphasis on working closely with our already contracted business to have a clear understanding of what portion of the building they will be using and then proactively filling the unused rooms with shorter cycle bookings (primarily corporate).

Our facility was in use a total of 333.25 days, hosting 175 events, 49 were first time events at the City Center.

The sales team at the City Center and the collective Saratoga Springs hospitality industry moved into 2017 with the knowledge that a significant increase in event space inventory was imminent. With the February opening of the Rivers Casino Event Center and the March opening of the Albany Capital Center, every opportunity to secure multi-year contracts and secure new business was made. Several highlights of new business developed include:

We are excited that many of our first time events will be returning in 2018. These event enhancements help to create an enriched experience for our clients and alternative revenue streams for the City Center.

The City Center team continues to enjoy a strong collaboration and partnership with the Saratoga Convention & Tourism Bureau, Saratoga County Chamber of Commerce, Downtown Saratoga Business Improvement District, Elected and Civic Leadership, and Hotel Partners. The goal remains to provide the best possible experience for our clients and enhance the economic vibrancy of Saratoga Springs.
